MEMORANDUM OF UNDERSTINDING

BETWEEN

It's Registered under trust registration Act 1860(year 1860 Rule 21) date 10 may 2018. It is a Not – for –profit Organization with fully Charitable objectives.

Now therefore Hirwal Education Trust's College of Computer Science and Information Technology, Mahad-Raigad (HET's CCSIT) and Vishwabhushan Foundation, Nimgaon Jali, enter into a Memorandum of understanding/agreement of cooperation to establish a program of exchange and collaboration areas of benefit to both parties.

I

Purpose:

- To promote interest in teaching and research activities of the respective institutions.
- To deepen the understanding of the economic, cultural, educational and the social issues environment of the respective institutions.
- Be the anchor to the needy by offering services to community.
- To organize knowledge sharing sessions.
- To generate and provide fund for needy and poor students as a scholarship, as well as teachers for research activities.





Type of Co-operation:

- Promote institutional exchanges by inviting experts of the partner organization to guide in a variety of research activities and curricular, co-curricular, extra-curricular activities.
- Carry out joint research programs in order to deepen the analysis and understanding of sciences and technology of the respective organization.
- Exchange information pertaining to developments in education/research at each institution.
- Institution shall organize an awareness seminar that will be conducted amongst the college youth and students waste as well as water as resource and its relationship with climatic changes.
- To arrange Extension and outreach activates/ program to sensitize student about social issues, environmental issues, gender issues and sustainable practices.
- The institution shall make proper arrangement for the awareness lecture & provide entire support to conduct the activity and seminar
- Organization shall provide the experts in relation to activities.
- For funding institution shall provide appropriate information of the students and teachers to organization.

III

Responsibilities:

- To promote academic, social collaboration at faculties and both graduate and postgraduate students level for research and study.
- To act as principal contacts for individual and group activities and to do plan and coordinate all activities within their institutions as well as with the partner institution / organization.
- To distribute to each institution information about the faculty, facilities, research, publications,
 library materials and educational materials, resources of the other institutional.
- To meet periodically to review and evaluate past activities and to work out new ideas and concepts for future cooperative agreements.





Regulations:

- 1) This memorandum of Understanding will be identified as the parent document of any program agreement executed between the parties. No modification, alteration of amendment of this Agreement will be effective unless in writing and signed by the both institutions.
- 2) This Memorandum is not a contract. This memorandum serves only as a statement of the general intention of the parties and is not intended to be legally binding nor to be construed as an agreement on any matters mentioned. No oral agreement or conduct of the parties (including partial performance) in respect of matters stated in this Memorandum shall be deemed to impose any obligation of liability on either party.
- 3) This memorandum is not intended to constitute, create, give effect to, of otherwise form a joint venture, or other business entity of any kind. Neither party shall act as an agent for, or party of, the other party. There are neither any right nor obligation of the parties established under this Memorandum/Agreement.
- 4) Both Institution can conduct or allowed the teachers/student and facility conduct the workshop, seminar, conference or attend its, these are no financial implication and binding.

V

This Memorandum/Agreement is approval by each institution, this Memorandum /Agreement will remain in effect for a period of three (3) years from the date of agreement, (i.e. from AY. Academic Year 2022-23 to 2024-25), unless terminated earlier by either institution, such termination by one institution shall be effected by giving the other institution at least three months advance written notice of its intention to terminate. If such notice is given, this Agreement shall terminate (a) at the end of such three months of (b) when all students enrolled in a course of study pursuant to a program. Agreement at the time such notice is given have completed their respective courses of study, whichever event occurs last. Termination will be without penalty. If this memorandum /Agreement is terminated, neither Hirwal Education

Trust's College of Computer Science and Information Technology, Mahad-Raigad nor Vishwabhushan Foundation, Nimgaon Jali, will be liable to the other for any monetary or other losses which may result.






Notwithstanding the above, the period of this cooperation will, if necessary, be extended with consent in writing from the parties.
