The Statement of Objectives

1. It is intended to have collaboration between the ICS and V.B for joint efforts in the area of biodiversity conservation.
- 2) To plan and execute indigenous tree plantation programs in rural areas within India.

It is also agreed to spread awareness about the protection and importance of biodiversity for present and fixture generation of the nation.

Furthermore to have inclusive participation from students as well as teachers and other stakeholders from society. One of the objectives is to carry research projects to inculcate research values amongst students and to contribute towards environment protection. V.B.

Motivate students to volunteer for social cause and to encourage them to participate in the various activities for protection of biodiversity of world famous Western Ghats

5. To inculcate good habits amongst students like planting trees, keeping surroundings clean. adapting different techniques to protect the environment, eco-restoration, etc.

Execution

1. It has been agreed that at least two activities in a year about objectives shall be undertaken in joint collaboration between both the parties to this indenture.
2. The ICS shall organize lectures of experts from the V.B regarding protection of the environment and also to spread awareness among the students about importance of environmental.
3. The experts from the V.B. will tender guidance to the students from the ICS for environment related activities.
4. The experts from V.B shall guide students and other stakeholders for indigenous tree plantation program to be undertaken yearly.
5. The ICSC will provide students volunteers for tree plantation and other activities of the V.B Financial Obligations, the V.B shall provide optimum finds to carry out tree plantation.

The experts from V.B shall be entitled for honorarium as per the University of Mumbai norms born USC for the lectures delivered and for guidance to students for biodiversity related activity.

The V.B and the ICS shall bear the transportation expenses equally.



1. The ICS shall not be responsible for criminal acts of participation. The objective of this memorandum of Understanding is not to make any profit, so no legal action shall lie for any loss or profit or other monetary damage.

With respect to research project(s), ICSC and V.B. share equal responsibility. D)

Liability for Default

This MOU will be operative for three year from June 2021

In case any mishap or accident during travelling or any event activity planned, the ICSC and V.B shall not be liable to pay any damages or compensation to the students or family members and also to take undertaking.

It shall be responsibility of the ICSC to make their students aware of these rules of this Memorandum of understanding.

The ICS will take responsibility to instruct their students to maintain the discipline when the events and activities are to be carried out.
